Councillor John Glover, Chair of Council – welcomed Ms. Cathy Jackson to the meeting.

Ms. Jackson (Project Lead – Play & Stay at Dyserth) advised Members in relation to the following: Confirmed receipt of two grants from Denbighshire County Council's commuted sums which totalled £34,000.00. A further sum of £20,000.00 had been agreed by the Post Code Lottery. One play area company / manufacturer had been appointed by the Group, whereby the majority of equipment will be accessible for wheelchair users. The total project costs will be a quarter of a million pounds, with £2000,000.00 to be spent on equipment. Ms. Jackson advised in relation to the remainder of the project – which included a feasibility study for public conveniences. The Clerk

referred to the disc roundabout that required repairing. Ms. Jackson agreed to incorporate in the new play area equipment an item to replace the roundabout. Other funding outlets were discussed with Ms. Jackson advising that the Group were gathering votes for a Calor Gas grant and requested Councillors to vote for the project.

The Chair of Council, together with Members congratulated and thanked Ms. Jackson for the work that had been successfully completed to date – and wished the Group their best wishes for future successful funding applications.

#### 1(E). 92/19

Councillor John Glover, Chair of Council – welcomed Mr. David Cook to the meeting.

Mr. Cook (Dyserth Junior Football Club Committee) advised Members, in relation to the current situation to the proposed building / structure for the football changing and toilet facilities. Whilst there were three proposals being considered by the Committee, a further suggestion in relation to an area of land on the edge of Dyserth Village could be leased to provide a Sports Building facility. Mr. Cook advised in relation to the number of teams and leagues, whereby more than one football pitch was required.

Mr. Cook agreed that he will approach the landowner of the suggested site and report back to the Community Council, at the July meeting.

The Chair, Councillor John Glover, thanked Mr. Cook for attending and for providing the update.

Minute no: 9. 75/19 sub minute no's: 4. 50/19 & 6(B). 36/10 (iii) (page 2) - in relation to an updated valuation on The Pavilion building. The Clerk advised that Peckover's had not replied to a number of e-mail reminders.

**Members agreed the following:** To carry out a valuation during the next financial year.

Minute no: 9. 75/19 sub minute no's: 4. 50/19 & 5(A). 51/19 (v) (pages 2 and 3) - in relation to a meeting to be held with Mr. Adrian Walls (Denbighshire County Council Footpaths Officer). Councillors' Mrs. Margaret Williams and David Williams provided the following report: Confirmed that a site meeting had been held with Mr. Adrian Walls, together with a colleague. The following had been agreed: (1) a temporary bridge to be erected (2) hand rail to be provided (3) River course is correct (4) Flood prevention scheme by Natural Resources Wales (5) temporary bridge to access the concrete area (6) filling of pot holes on footpaths.

Minute no: 9. 75/19 sub minute no's: 6(A). 53/19 (a) (page 4) - in relation to a quotation for repairs to the Multi Use Games area.

**Members agreed the following:** To accept the quotation for the sum of £2,295.00 plus VAT.

**Members agreed the following:** Not to proceed with the repair to this play item – pending a replacement play equipment from the Stay & Play at Dyserth. The Clerk to ascertain from Aura Leisure if the equipment can still be used.

Minute no: 9. 75/19 sub minute no's: 9.61/19 (page 4) - in relation to 'Welcome to Dyserth' signage. County Councillor David Williams advised, that it was not possible to arrange a site visit with Officers from Denbighshire to all the locations. Councillor Trebor Evans advised in relation to a number of areas identified on new plans which had been received from the Clerk to the Council. Councillor Evans also referred to the boundary areas of the Community Council.

**Members agreed the following:** Councillor Trebor Evans to formally identify the sites for the new signage and to advise at the July Council meeting, in relation to the size or sizes required.
