TO APPROVE THE MINUTES OF THE MEETING HELD ON THE 10TH NOVEMBER 2025

PROGRESS REPORT ON MATTERS RAISED AT PREVIOUS MEETINGS

The Clerk referred to the following matters from previous Minutes:

- (1) Dyserth Kilns:** The Clerk advised Members that a meeting was arranged on Tuesday 27th January in The Pavilion Building with Amanda Pearson and Lowri Goss to discuss Phase 2 of the Dyserth Kilns project. The meeting will include the Kilns Sub-committee of Councillors' John Glover, Andy Hughes, David Parry and Peter Robinson – together with the Clerk.
- (2) Dyserth Waterfall:** Councillor Andy Hughes provided an update to the legal process of registering the Waterfall Committee.
- (3) Street Lighting Electricity Supply:** The Clerk recollects Members to the monthly invoices being received from Scottish Power in relation to the continual usage of the street lighting supply every month for Christmas street lighting. The invoices state a monthly standing order charge, with one month's invoice included supply usage, whereby no supply had been used. Following a formal complaint to Scottish Power (SP) the matter was thought to be resolved with SP agreeing to refund the payments made by the Council – which have not been received to date. Whilst the matter was supposedly resolved the Council have received further invoices for payment. The Clerk is in further contact with Scottish Power.

CLERK'S REPORT

- (a) Received from and deposited into the Council's bank account:
- Denbighshire County Council - £17,250.00: Third precept payment for financial year 2025 / 2026.
 - Denbighshire County Council - £2,474.43: Commuted Sums grant – Children's Play area repairs (wet pour)
- (b) The Clerk advised that the repaired Speed Indication Signage in the area of Tre Castell in Dyserth was back in situ
- (c) The Clerk advised that there had been a concern with the locking up and closing of the Red Telephone Box in Dyserth. Councillor Anne Rogers provided further information
- (d) The Clerk advised that following discussion with the Dyserth Bowling Club Committee, the awkward locking system for the Pavilion Building outside gate has been changed to alleviate the concern
- (e) The Clerk recollects to Members the Council's Bio-diversity end of year report that had recently been agreed and submitted to the Welsh Government – via One Voice Wales to upload to a dedicated web site for all Councils in Wales. A reply had been received from the One Voice Wales Biodiversity Officer which stated the following: 'A mighty impressive report – well done'
- (c) Concerns reported to Denbighshire County Council:
- (i) Overgrown privet hedge at lower end of Bron Deg & Cwm Road, Dyserth. Denbighshire County Council will write to the property owner
 - (ii) Damaged metal railings on A5151 Road at Waterfall Road junction (Near traffic lights). (Photograph supplied). No response from Denbighshire Street scene
- (d) North Wales Police: The Clerk advised that the allocated PCSO will attend the commencement of Council meeting subject to their rota
- (e) Councillor Ian Clayton will attend the following training courses facilitated by One Voice Wales:
- (i) New Councillor induction on 10th February
 - (ii) Code of Conduct on 18th February
- (f) **HM Land Registry**
- The Clerk advised that a Notice of an Application for Registration of a person in adverse possession – B149 had been received by this Council from the HM Land Registry

The applicant has instructed a legal firm to represent to acquire a title of land by adverse possession namely: Land at Ardwyn, High Street, Dyserth. Members were shown on screen the application and plan.

Members agreed the following: To consent to the registration of a person in adverse possession in relation to the property, at land known as Ardwyn, High Street, Dyserth. The Clerk to sign the consent document on behalf of the Community Council and return to the Land Registry.

(g) Wales Audit 2024 / 2025

- (a) The Clerk advised that the Wales Audit return for year ended 31st March 2025 had been received. The Chair and Vice Chair had been sent a copy of the return following receipt in December 2025. Members perused a copy on screen.

Members noted the following Audit Opinion: ‘Unqualified - On the basis of my audit, in my opinion no matters have come to my attention to give cause for concern that, in any material respect, the information reported in this Annual Return’.

The Clerk further advised that the following Public Notice had been displayed on the Council’s web site and notice board: Notice Of Conclusion Of Audit And Right To Inspect The Annual Return For The Year Ended 31 March 2025. Public Audit (Wales) Act 2004 Section 29 Accounts and Audit (Wales) Regulations 2014.

Members agreed the following: Noted the Wales Audit qualification and thanked the Clerk for his financial duties.

TO APPOINT A COUNCILLOR TO VERIFY, SIGN AND DATE BANK STATEMENTS

The Clerk recollects to Members that this process is required under the Council’s Financial Regulations.

Members agreed the following: (1) Councillor David Jones appointed to verify, sign and date bank statements for the quarter: October, November and December, 2025 (2) Councillor Jones confirmed to Members, that the bank statement reconciliations agreed with the end of quarter - as per below Minute - to receive and approve the quarterly statement of accounts to the 31st December, 2025.

TO RECEIVE AND APPROVE: QUARTERLY STATEMENT OF ACCOUNTS TO THE 31ST DECEMBER, 2025

The Clerk, as Financial Officer provided Members with a copy of the Quarterly Statement of Accounts, as at the end of December 2025. (Electronic copies sent prior to the meeting to Councillors). The Clerk further provided Members with a breakdown in relation to the budget headings, which included income and expenditure to date. The financial documents were shown on screen together with bank statements.

Members agreed the following: Approved the Statement of Accounts, whereby the document was agreed to be signed by the Chair of Council Councillor Anne Rogers.

TO RECEIVE, CONSIDER AND APPROVE: BUDGET FOR THE FINANCIAL YEAR 2026 / 2027

Members agreed the following:

- (1) To increase the current precept for the forthcoming financial year from £51,750.00 to £70,000.00 – an increase of £18,250.00. The Clerk advised, that the Band D property charge would be £59.73, an increase of £15.98 a year (36.38% - £1.34p extra per month).

In reaching their decision to substantially increase the precept, the Council Members took into consideration the following: Over past years the Council have kept their precept increase under 3%. This has now reduced the level of funds in the general, ear-marked and emergency reserves budgets. To ensure that public conveniences are available in the area of lower Dyserth, the Council have agreed with the Waterfall Committee to fund portable conveniences in the car park adjacent to the Waterfall, at an approximate cost of £7,000.00 a year to this Council (£4,000 hire of portable toilets and £3,000 – towards ear-marked reserves for a future Community Asset Transfer of the current building). The Council wish to improve the play area, to continue with the current maintenance contracts, including property upkeep and various projects.

- (2) The ear-marked reserves budget was updated.
- (3) The Chair of Council Anne Rogers to sign the estimates for the end of the financial year 2025 / 2026, including the precept requirement for 2026 / 2027.
- (4) The Clerk to advise Denbighshire County Council, in respect of the Community Council's financial requirements (precept) for 2026 / 2027.
- (5) **Glascoed Timber Dog Bin Emptying Contract:** The Clerk advised that there is no other company in North Wales that advertises a service to empty dog bins. Denbighshire County Council empty their own bins but do not allow contracts with Town & Community Councils.

Members agreed the following: To suspend the financial standing orders in relation to seeking three quotations for the dog bin emptying service, this is due to the limited availability for this type of service.

The Clerk advised that this is an annual agenda item in January of each year. The Clerk further advised, in relation to the appointment process for the Council's Internal Auditor.
